### **Increase in Child Sexual Abuse Related to Sextortion**

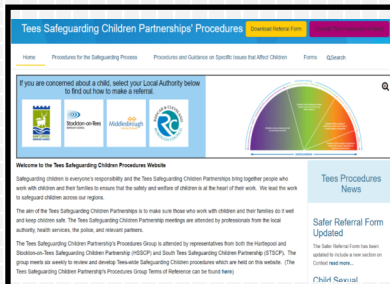
The Internet Watch Foundation has published a news story about an increase in the number of younger children exposed to sextortion in the UK. Reports of child sexual abuse related to sexual extortion were up 19% compared to 2024. There was also an increase in reports involving 14-15 years olds and an increase in reports involving girls.
